Mrs A. Corson, trainer of **REBEL WOMAN** running in the fourth, requested that her horse be allowed to go post early. The Stewards considered the request and granted permission.

The Stewards noted there were a number of late declarations for equipment and take the opportunity to remind trainers of Rule 60.

Rule 60

(i) (a) If a horse is to run in a hood, blinkers, visor, eyeshield, eyecover, sheepskin cheek pieces or a tongue strap, a declaration to that effect must be made at the time of Declaration. (b) If a horse is to run in a hood fitted with blinkers, both must be declared, as must any combination of hood, blinkers, visor, eyeshield, eyecover or sheepskin cheek pieces.

(ii) (a) When a horse has been declared to run in a hood, blinkers, visor, eyeshield, eyecover, sheepskin cheek pieces or any combination thereof, they must be worn by the horse on the way to the Start and during the Race. If it is not possible for the horse to wear them, he shall not run.

(b) When no declaration of hood, blinkers, visor, eyeshield, eyecover, sheepskin cheek pieces or any combination thereof has been made, they must not be worn by the horse on the way to the Start or during the Race. If they are worn on the way to the Start, the horse shall be withdrawn by the Starter and the horse shall not run.

The Stewards interviewed Mr. K. Kukk, trainer of **STEELY**, ridden by Mr M. Quinlan and reminded him that permission for the hood worn by his charge only extended to the Parade Ring and not the chute.
